### The Nature Conservancy Release of Liability

**Preserve, County, State:** Sweetwater Preserve, Fremont County, Wyoming

**Description of Activity:** Participant is engaging in a handcart trek (the Activity) over and across portions of The Nature Conservancy's (TNC) Sweetwater Preserve (the Preserve). The Activity is organized, managed, led and otherwise solely supervised by The Church of Jesus Christ of Latter-day Saints

In consideration for receiving permission from TNC to participate in the Activity on the Preserve, I agree as follows:

1. I understand the nature of the terrain and the type of Activity in which I will be participating, and I am capable of safely undertaking this Activity.
2. I understand the dangers involved in this Activity on the Preserve and agree to take all reasonable precautions to avoid injury to myself and others and damage to the Preserve in connection with my activities.
3. I am engaging in the Activity at my own risk, and acknowledge that TNC makes no warranties or representations, express or implied, regarding the condition or safety of the terrain for the purposes of the Activity or any other purpose.
4. On behalf of myself, my heirs, successors and assigns, I hereby forever release, indemnify and hold TNC, its officers, directors, employees and agents, harmless from and against any and all claims, liabilities, losses, damages, costs and expenses arising from or in any way related to my participation in the Activity. I intend this release to be effective, regardless of whether the claim of liability is asserted in negligence, strict liability in tort, or other theory of recovery.
5. I agree to go into only those areas authorized by TNC and to comply with all Conservancy rules concerning the Activity. Preserve rules include the following:
  - a. I will remain on designated roadways, which may be rough and rocky.
  - b. I will keep my distance from any observed wildlife or wildlife habitat such as nests or dens.
  - c. I will not remove any plants, flowers or other wildlife from the Preserve.
  - d. I will use identified restrooms only, which are located on properties outside of the Preserve.
  - e. I will ensure that I leave no waste or trash on the Preserve.
